## Our Mission

The mission of Rainbow Bridge Parenting Time Center is to provide a safe environment to bring about the physical transfer of/or visitation with children without contact between the parental parties.

## Setting Up Services

- To begin using services, individuals should contact the Rainbow Bridge office in order to schedule an intake appointment. Intakes are done between 8:00am and 4:30pm Monday-Friday. All parties must complete an intake in person before services can be implemented.

Rainbow Bridge cannot force a person to agree to services.

## Our Services

### Supervised Parenting Time:

The most secure service that Rainbow Bridge provides. Both parent and child(ren) are under the direct supervision of a staff member for the entire visit. Parenting time sessions are scheduled for a maximum of two hours. The sessions occur in a family room that is comfortable for parents and entertaining for children.

### Supervised Exchange:

- This service provides a supervised exchange of children between custodial and non-custodial parents, monitoring the separate arrival times and supervising departure. During this service parents do not come into contact with one another, ensuring that the children are not caught in the middle of any conflict.

### Transitional Supervised Parenting Time:

These visits are provided in the same environment as traditional supervised parenting time, but without constant supervision being provided by our staff. Rainbow Bridge staff monitors the arrival and departure of each parent. The staff is available to assist children or parents when needed.

## Court Orders

- Rainbow Bridge does not require a court order for use of services, but does require a copy if one is in place. Rainbow Bridge has no legal jurisdiction; we will use the court order as a guide but are under no obligation to follow what is listed. Rainbow Bridge does not have the authority to enforce court orders; therefore, if a consensus cannot be reached between both parties regarding scheduling, no activity will be scheduled.
